1. Commercial Exhibition

The **1st MONOGRAPHIC COURSE OF SECPRE** will take place at the Church of the Universidad Laboral de Gijon on June 1st and 2nd 2018.

Facilities

Each booth measures 3m x 2m (6 sqm, 3 m wide and 2 deep), being able to rent more than one space.

Spaces and booth construction

Space rental does NOT include booth construction. Only the electrical panel is included.

If you wish to hire the construction of the modular booth or design, please indicate it in the Space Order Form.

All booths shall comply with the standards provided by the Universidad Laboral de Gijon (see attached).

Setup and dismantling

The setup of booths will take place on **31st May**. The Exhibit will start running on 1st June in the morning, at the beginning of the Course, and will be open during the Course days (1st & 2nd June, 2018).

The exhibitor shall take care of the transport and insurance of all material of his/her property.

The dismantling will take place on 2nd June once the sessions are finished.

Fees and conditions

Rental price includes the electrical panel. If you wish to hire the construction of the modular booth, please indicate it in the Space Order Form and it shall be budgeted separately. All booths shall comply with the standards provided by the Course Centre.

Booths shall be allotted in a first come first served basis according to the Contract Order Form. Booth requests shall be submitted to the Course Secretariat together with the Space Order Form.


